Welcome & Announcements.

Subject: Summary of the Wednesday, October 7, 2009, BoRit CAG Meeting

- Agenda for the meeting reviewed.

Communication Workshop Summary and Discussion.

- Summary from the communication workshop held on December 2nd, 2009 was discussed. During this workshop, the CAG learned that they perform best when there are specific tasks to discuss. It was proposed to not have meetings if there are no new agenda items. The majority of the CAG would like to hold monthly meetings.
- Eileen offered to provide an open list of agenda items. Some members discussed the benefits of having action items attached to the agenda and having them prioritized as to when they need to be answered by.
- There was discussion over shorter meetings or having some meetings specific for sub-committees. No final decision was made regarding this discussion.
- Sal concluded that agenda items need to be clear and any decision needs to be made before moving on to the next item of business.
- After inquiry, Francisco, EPA stated that the CAG has been approved for three facilitations that are available to the CAG upon request. Management is still looking at the 12-month plan. The facilitator is open ended; either Melinda or another facilitator within E2 may be chosen.

CDM Presentation of the Summary of Phase 1 Remedial Investigation Activities through December 2009 at Borit Superfund Site, Ambler PA.

- Presentation given by Lucinda J. Pype. Questions were answered throughout presentation.
- For this remedial investigation, the EPA has chosen to use PLM. Lucinda will check with EPA to determine why the TEM was not used.
- This investigation is for Phase I only. Areas such as where the homes were on the Wissahickon Alley and home sampling is not part of Phase I. At this point, EPA is gathering baseline data. Phase II has not been discussed yet since information from

Phase I is still being acquired. Validated data will not be available to the EPA for at least 30 days. An estimated guess of the official results will be available to the CAG as of late spring or early summer. Francisco will discuss with Stacie, EPA, about getting these results out to the CAG prior to beginning Phase II so that the CAG can have input into what Phase II entails.

- There were multiple concerns over baseline sampling of ambient air. Francisco stated that Eduardo has been collecting air samples for the last 2 years, several times a month when possible. Certain CAG members voiced wanting a systematic approach to collecting air samples in order to put the community's concerns at rest. Air sampling will be discussed at a future meeting so that members can prepare for a proper discussion about this concern.

Observer Comments.

- Vance Evans, EPA, stated that it is standard protocol to start data collection at the site property and then work outward from this starting point.

Public Awareness Group Initiatives in 2010 Discussion.

- Lynn Hoffmann presented on behalf of the Community Awareness Group. One of the tasks of the Community Awareness Group is to determine the best way to get information out to the community. Multiple methods were discussed and listed below;
 - A letter to the Editor
 - Handing out CAG business cards
 - Website
 - CAG Newsletter
 - Article in the Gazette
 - Look at other CAG organizations and use their methods
- It was suggested to have a facilitated session on how the CAG should respond as a group to the community.
- The Community Awareness Group will draft a "Who and What is the CAG" and present it to the group by the next meeting.
