6:45 p.m. Presentation by Jack Kelly – Nicolet Buildings

- Former K&M (Nicolet) Buildings: Activity Based Sampling Photos and Results
 - o Mr. Bass (owner) is in the process of demolishing the Manufacturing Building, clearing began in August, and demolition began in October.
 - o Demolition is being done on about 6 buildings. Demolition guidelines follow the NESHAP Law, not the Superfund Act.
- Asbestos was found in building, mostly found in a pipe that ran through building
 - o Stationary air samples were done with high and low flow samples. Thirteen samples were taken.
 - o Since teenagers got into the abandoned building, the workers tried to replicate teenagers using spray cans to create disturbance during ABS.
 - o June 15th, 2010: Sampled air while doing ABS within Manufacturing Building and Processing Building.
 - 2 people for 2 hours
 - o On June 18th, air samples were taken without ABS. Wind was coming from the NE on both days.

 - o What to do about groundwater pollution discovered during Phase I,
 - Seep at base of reservoir berm could be a wetland/spring, was investigated as a part of WVWA reservoir Phase I study.
 - Groundwater pollution could affect other asbestos piles, or drinking water
 - o Air sampling should be done on the White Mountains to determine if cap is still effective
 - o Lora Werner is compiling data base of private wells
- DEP
 - o Recommendations for private wells safety
